I hereby extend my sincere gratitude towards your support, cooperation and appreciation extended with regard to dedicated online platform. In continuation of the FEE CIRCULARS being issued under the lockdown and post lockdown period we hereby are incorporating directions of the Division Bench of the Hon'ble High Court at Calcutta in WPA No. 5890 of 2020 dated October 13, 2020.

1. Parents and guardians of students are offered the option of paying fees as per the revised fee structure till such time as reopening of the school in physical mode are as follows.

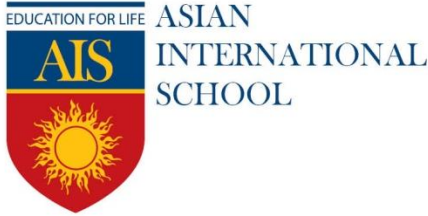

2. Accordingly, parents/guardians who have paid 100% of the tuition fees as on date of this intimation and/or intend to pay and/or continue paying 100% of such tuition fees and/or have paid 100% of the session fees and/or intend to pay 100% of session fees are requested to do so.

3. In the event the parents who have paid 100% of tuition or session fees wish to avail of the reduction indicated as in the above **TABLE A**, they will not receive any refund but will have the balance in their favour adjusted against payment of tuition fees for the period subsequent to November 30, 2020.

4. The **tuition fees** as per the **TABLE A** provided above for the period commencing from **April 1, 2020 up to November 30, 2020** will have to be tendered by **November 30, 2020**.

5. Initially the session fees was payable by 10th April'2020, subsequently as per **FEE CIRCULAR – III dated July 1st 2020**, the same was allowed for Bi Annual submission until **30th of September 2020**. The session fees prescribed in **TABLE B** as above have to be paid by **November 30, 2020**, if not already paid.

7. In the event no application is made by November 15, 2020 and the fees prescribed in TABLE A and B above are not paid by November 30, 2020, the concerned student will not be entitled to attend school in any mode and will be denied all facilities being offered by the school.

Note: Since the advent of this pandemic AIS always strived to support the student fraternity vide its FEE Circulars from time to time waiving all non-essential charges, much before any Honourable Authority intervening in the matter. We have been the only school which has provided dedicated online platform to its students from the commencement of online classes i.e. since APRIL 2020. In our efforts to indemnify the parents against the charges levied for the paid platform, school had taken and continues to shoulder the responsibility to accommodate such additional charges. Transport Fee, Late fee have also been completely waived off in these pandemic times. School was never closed only the buildings were closed, which too have now open for staff members. The teachers and staff members have worked harder and are committed to continue the efforts.

NB:

A. The above information is being furnished without prejudice to the right of the school to challenge the order dated October 13, 2020 of the Hon'ble High Court and is subject to any further orders that may be passed by the Hon'ble High Court and/or the Hon'ble Supreme Court of India, as the case may be.
